The best way you can do this is to include our charity as a beneficiary in your Will and other estate planning documents.

A Will is the most common way to make an after-death gift to our charity. The basic way to include our charity as a beneficiary under your will is to insert the following language (which you or your own lawyer may wish to modify):

Bequest of the remainder of an estate (i.e., the amount left over after all specific bequests have been fulfilled):

"I give, devise, and bequeath to Call to Holiness Canada Ltd. (also known as "Perpetual Eucharistic Adoration") a federally incorporated registered Canadian charity # 890624927RR0001, all [or insert the desired fraction or percentage] of the rest, residue, and remainder of my estate, both real and personal. A handwritten, dated, signed Codicil note attached to an existing valid Will is acceptable in some cases.

A typed Codicil, signed by two witnesses, (who must not be beneficiaries of the Will), in the presence of the person who is signing their Will may be acceptable. The witnesses would also need to sign an Affadavit, to include with the Will, attesting their witnessing. We do have a lawyer friend who could provide a copy of a standard Affadavit if required.

Other useful vehicles for making donations are intervivos or testamentary trusts, and registered plans such as RRSPs, RRIFs, or TFSAs, as well as insurance policies and annuities of various kinds, where Call to Holiness Canada Ltd. can be listed as a **beneficiary**.
